Kidney Patient Advocate Dawn Edwards Talks Sepsis



Social Determinants of Health (SDOH) Screening

Screening for the social drivers of health was included in the QIP measures as reporting measures starting in calendar year 2025 – you can find the technical specifications for these measures at this <u>link</u>. There are no specifications for who completes the screening or which tool is used, the measure is just looking at how many patients 18 years of age and older are screened for five health related social needs: food insecurity, housing instability, transportation needs,



utility difficulties, and interpersonal safety. Please see pages 36 – 39 of the document in the link above.

EQRS



There are several reports and dashboards available in EQRS to support your quality improvement efforts and confirm complete and accurate data. Click on the **Reports** drop down menu on the navigation bar in EQRS and select **Reports Dashboard** to find dashboards related to vascular access, vaccinations (influenza and pneumococcal), clinical depression screenings, and hemodialysis and peritoneal dialysis clinical measures. There is also a transplant waitlist report available from the **Dashboard** tab on the navigation bar in EQRS that includes information about the waitlist status of your dialysis patients. This <u>tip sheet</u> has more information about the various dashboards available.
