


EQRS DASHBOARDS & REPORTS

There are several dashboards available in EQRS supporting your work to improve the quality of care for kidney patients. If you don't have access to EQRS and would like access, follow these simple steps to register: HARP & EQRS Quick Start Guide

VACCINATION DASHBOARDS (INFLUENZA AND PNEUMOCOCCAL)

Use these 2 dashboards to view a list of the patients in your center who have received the flu and pneumococcal vaccine. Many facilities have used these dashboards to improve their vaccination rates by conducting a data reconciliation; comparing the EQRS dashboard list to the state immunization registry to capture additional immunizations that patients may have received outside the dialysis facility.

There are several <u>vaccination resources</u> on the MKN website, including the <u>Managing Patient</u> <u>Pneumococcal Vaccination tip sheet</u>, if you have questions about your patient's pneumo vaccination status.

CLINICAL DEPRESSION DASHBOARD

This dashboard supports the reporting requirement for the Quality Incentive Program (QIP) and provides a list of patients at your facility, whether they have received their annual depression screening, and the results. An <u>EQRS tip sheet</u> is available on the MKN website to help you enter data into the Clinical Depression Dashboard.



HEALTH EQUITY ATTESTATION PAGE

The health equity attestation page supports the reporting requirement for the ESRD QIP. There are several <u>Health Equity resources</u> on the MKN website including links to social needs screening tools. <u>Slides</u> from the December 2023 CMS Town Hall Webinar provide guidance about how to submit the required health equity attestation.

VASCULAR ACCESS

The vascular access dashboard supports the vascular access measure in the ESRD QIP. This dashboard provides a summary of the facility's vascular access rates, including a long-term catheter rate, and patient-specific vascular access information. This <u>EQRS News Flash</u> includes more details about how to use the vascular access dashboard.

HD & PD CLINICAL DASHBOARD

The hemodialysis (HD) and peritoneal dialysis (PD) clinical dashboards provide summary information for some of the measures from the clinical data section of EQRS such as hemoglobin, Kt/V, albumin, and calcium. The dashboards include three reports:

- 1. Facility aggregate report the number of patients in the facility with a reported, missing, or NA value for the selected measures.
- 2. Averages report the average value of all the facility's patients for the selected measures.
- 3. Patient detail report the patient-specific values for the selected measures.

All of these reports can be exported to a CSV or Excel file.

DIALYSIS FACILITY TRANSPLANT WAITLIST

From the Dashboard tab on the navigation bar, you can download a list of your dialysis patients and information about their waitlist status including where they are waitlisted and whether they are active/inactive and why they may be marked inactive. Regularly reviewing this report will help to support your patient's successful journey to transplant.
