### **New 2728 Form October Release**

Friendly reminder that a revised CMS 2728 form is coming soon to the ESRD dialysis and kidney transplant community. The go-live date in EQRS is anticipated for October 2024. You should reference the FAQ guide,

<u>recorded training</u>, and an <u>overview of changes</u> to the revised CMS 2728. PLEASE NOTE: Initial CMS 2728 forms are always due for submission in EQRS within 45 days of the patient's start date at their first outpatient facility.
