Expansion of Dialysis in Skilled Nursing Facilities

Culturally and Linguistically Appropriate Services (CLAS)



Starting this year, you will hear more about CLAS and how to incorporate these standards into your facility services. We at MKN are in the middle of assessing facility's knowledge of CLAS and resources currently being used at the facility level. Our initial feedback is showing that it is not something most are familiar with and is an opportunity for us to provide education and resources. Paired with Health Equity, CLAS "is a way to improve the quality of services provided to all individuals, which will ultimately help reduce health disparities" per the HHS.gov website.

In the past we have provided 'technical assistance' to facilities in 8 specific clinical quality improvement areas as defined in our CMS Scope of Work. This year, CMS added **CLAS and Health Equity** to our scope of work. When the assessment is complete, we will be providing additional tools and resources specific to CLAS and health equity but please reach out to us if you have any questions on these topics.
