Health Equity Community Conversations Series – May 14th



Patient Identification Verification is Important!

Completing the CMS 2728 form accurately and timely is critical and can directly impact a patient's entitlement to Medicare under the ESRD provisions of the law. Collecting accurate patient information is also vital to maintaining the EQRS database and ensuring providers receive appropriate and timely reimbursement. As a friendly reminder, the name and social security number on the CMS 2728 should be the same information that appears on the patient's social security or Medicare card, and the patient's date of birth should also be verified so benefits can be assigned appropriately by the Social



Security Office. If the patient does not have a social security number, please call <u>Midwest Kidney Network</u> <u>data staff</u> so we can provide guidance about how to appropriately complete and submit the CMS 2728 form.

Revised CMS 2728 Form Coming Soon!



A revised CMS 2728 form is coming soon for all dialysis and transplant providers. In the meantime, please continue to use the 'old' version of the CMS 2728, until the revised CMS 2728 form goes live in EQRS. The switch between versions will happen automatically in EQRS. Kidney transplantation offers patients with end-stage kidney (ESKD) disease freedom from frequent, time consuming, and uncomfortable dialysis treatments. However, successful outcomes are not ensured, and transplant recipients face new challenges, including concerns about transplant rejection and the need to adhere to a complex regimen of immunosuppressive therapy that may generate distressing side effects. Depression is a condition prevalent among patients with ESKD undergoing replacement therapy. It has also been increasingly recognized among kidney transplant recipients.
